PRIVACY POLICY

To Whom It May Concern,

Summercon Holdco (Pty) Ltd (“**Summercon**”) is committed to protecting your privacy and giving you a safe online experience. This **Statement of Policy** applies to the **Summercon Website** (“the **Website**”) and governs data collection and usage. By using the **Website**, you consent to the data practices described in this statement.

1. Protection of Personal Information Act, 2013 (POPI)

You acknowledge that by using the **Website** and by trading with **Summercon** you will be providing **Summercon** with personal data which may be protected by data protection legislation, including, inter alia, the Protection of Personal Information Act, 2013 (POPI). You hereby authorise us to process all such personal data for the purposes of performing the business of **Summercon**'s legitimate business interests including statistical analysis, marketing of our services/product and credit control. You also authorise us to process and transmit your personal data in the manner contemplated in this **Statement of Policy**.

2. Collection of your Personal Information

Summercon collects personally identifiable information, such as your email address, home or work address/or telephone numbers, **Summercon** also collects anonymous demographic information which is not necessarily unique to you, such as your postal code, age, gender, preferences, interests and favourites.

Summercon encourages you to review the privacy statements of Websites you choose to link with **Summercon** so that you can understand how these Websites collect, use and share your information. **Summercon** is not responsible for the privacy statements or other content on **Websites** outside of the **Summercon Website**.

3. Use of your Personal Information

Summercon collects and uses your personal information to operate the **Summercon Website** and deliver the services / product you have requested or are interested in. **Summercon** also uses your personally identifiable information to inform you of other products or services available from **Summercon**. **Summercon** may also contact you via surveys to conduct research about your opinion of our current services/product or of potential new services/product that may be offered by **Summercon** in due course.

Summercon does not sell, rent or lease its customer lists to third parties. **Summercon** may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (email, name, address, telephone number) is not transferred to the third party. In addition, **Summercon** may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange deliveries. All such third parties are prohibited from using your personal information except to provide these services to **Summercon**, and they are required to maintain the confidentiality of your information.

Summercon does not use or disclose sensitive personal information, such as race, religion, or political affiliations without your explicit consent.
